We need a big turnout of caring neighbors to convince our elected representatives that they must be responsive to our continuing concerns. This

is your chance to ask questions and demand results from our elected representatives

Our featured speakers include **our Los Angeles County Supervisor Zev Yaroslavsky** (who also sits on the Metro Board of Directors, which is overseeing the 405 construction); **our Councilman Paul Koretz** (who can help us with City agencies that approve traffic mitigations and landscaping); **Mark Van Gessel, Metro project manager** for our segment of the 405 project; and our **LAPD Senior Lead Officer Chris Ragsdale**, who will address recent security concerns.

Our annual meeting this year marks the last time that **Zev Yaroslavsky** will be speaking to all our members as our County Supervisor, because his term expires next June. Zev has represented the Westside for nearly 40 years—first as our City Councilman (1975–1994), then since 1994 as our County Supervisor.

Zev and his staff (especially his wonderful deputy Vivian Rescalvo) have always been extremely constituent oriented. The last couple of years, they have really gone to bat for us with Metro on several 405 construction issues. It will be with great regret—and many thanks for his years of dedication—that we say goodbye to Zev as one of our elected representatives.

Remember, we're meeting in a new venue this year: the Westwood Presbyterian Church, 10822 Wilshire Blvd. (the south side of Wilshire, next door to the old Avco movie theater which is currently under reconstruction. There is plenty of surface parking on site.

Our Annual Meeting is always a great opportunity for us to get together in person—socialize, enjoy some delicious munchies, meet new neighbors, renew old acquaintances, and catch up on local news.

TRANSPORTATION UPDATE

I-405 Construction

After more than three years of construction, Metro now promises that the I-405 HOV lane and all new ramps will be complete and open to motorists by June 2014. However, landscaping of the 405 Widening Project, new signals and lighting, and resurfacing of Sepulveda Blvd. will still need to be completed.

Great News About Landscaping!!

As a result of much prodding from WHPOA and our elected representatives, Metro, LA County, and LA City have agreed to plant and maintain trees and vines along Sepulveda from Wilshire to Sunset. The new landscaping plan is a vast improvement over the original, which provided only a few trees at Sunset and at Montana, while leaving all the retaining walls bare. We have been promised more trees and shrubs, and all new retaining walls will have vines planted at their base. It will be nice to see plants growing along Sepulveda after 4-5 years of destruction, construction trucks, dirt, lane closures, more dirt, detours, flying dust, and construction equipment pounding, drilling and beeping all night!

LA2B

City planners and LADOT's have a new concept for transportation for our city, emphasizing a "multimodal" approach. The private car will no longer be king of the road. Road space will be shared with bikes, pedestrians, and buses.

Bus-Only Lanes Will Be Added

Wilshire Blvd. will be reconfigured to accommodate a peak period (7am-9am and 4pm-7pm Monday through Friday) curbside Bus-Only Lane from the Santa Monica city line (Centinela Av.) to downtown LA (at Valencia St.), except in Beverly Hills, which has opted out of the program. The Wilshire BRT (Bus Rapid Transit) is estimated to be complete by November 2014. Bicycles will be allowed in the bus lane. Vehicles wishing to make right turns will be allowed into the bus lane near the intersection in order to turn right. Bus ridership is expected to increase 15 – 20% as the bus transit times improve 24%.

Plan Adds Westwood Bike Lanes

Cycling activists have pushed forward a 2010 Bicycle Plan that aims to make LA a bicycle-friendly community. As streets are made safer places to ride a bicycle the number and type of bicyclists is expected to increase. Over the next 35 years the City intends to expand bike lane/bike paths/bike ways from the current 334 miles to a total of 1,684 miles.

Currently of importance to the Westwood area is the initial rollout of bike lanes. A bike lane being planned for a narrow section of Westwood Blvd. between Santa Monica and National Blvd. will require removing a southbound traffic lane and eliminating all peak-period parking. Westwood Blvd. between Wilshire Blvd. and Santa Monica Blvd. is much wider and currently has striped (Cont'd. p. 5)

Public Art Planned for Walls 1720 and 1730

Greenmeme, the artist commissioned by the City to design art for the massive Sepulveda Blvd. retaining walls known as 1720 and 1730 (north and south of Homedale) has proposed installation of sandblasted motifs incorporating images drawn from nature, e.g. trees, and the surrounding community, e.g. Royce Hall. Metro's Community Advisory Commission endorsed the most recent design, which goes before the Cultural Arts Commission on November 7, in preference to an earlier proposal that had been opposed by the WHPOA Board. Metro estimates that installation of the art will take five to six weeks of nighttime work and will require Sepulveda Blvd. to be fully closed while work is in progress.

This photograph, taken from the Getty, shows the massive walls on which the City proposes to install public art pursuant to its program requiring 1% of construction costs to be devoted to public art. The walls, required to facilitate the City's widening of Sepulveda Blvd., are on City property although the I-405 Project paid for the widening.
