When to call 911	1 - Any encampment in a high fire zone! Anything between Sunset Blvd and Mulholland qualifies. 2 - Behavior that threatens public safety: weapons, terroristic threats, attempted battery, setting fires (including their own belongings or trash cans), throwing objects into a roadway or at others - take photos or videos so outreach workers and LAPD know they have found the right person;		
Mental Health	It can be tough to determine when a mental health issue is a "911" call or not. If someone appears to need help but they are not threatening others in any way, first report to LA-HOP.COM , then call DMH Access Team at (800)854-7771 and See this link for a complete list of resources.

Social Service Outreach For Veterans	Take photo and note location of person(s)	Send email with photo and locations to: <u>Shanna.Nelson@VA.gov</u> , Outreach Director West LA VA – 310 268 4045	The VA Outreach team will attempt to locate the person(s) and verify if they are eligible to receive VA services.
Enforcement For Non 911 Homelessness Issues	Call the correct jurisdiction: Brentwood comprises City, County & hillside/Mountain Conservancy areas. See <u>Trail Map for MCRA here</u>	If the issue is located on the SIDEWALK adjacent to the VA on San Vicente - it is COUNTY land and the SHERIFF patrols the area; all other areas in 90049 are LAPD and/or Park Rangers for some hillside areas. Trespassing on Private Property	Fill out this form and file it with the West LAPD in person or email LAPD SLO Matt Kirk 34713@lapd.online	See this to Post Proper No Trespass Sign 1 - Note the proper Trespass wording 2 - Must have correct LAMC Code that allows LAPD to enter and arrest after filing a form.	Contact LAPD when there is a trespass incident and take photos/videos if possible. The person(s) will be asked to leave or detained.
Sanitation, Dumping, Bulky Items, Blocking ADA access to sidewalk, blocking a fire hydrant.	Take photos, note location and report sanitation, dumping and bulky items to MyLA311 Report ADA Access and fire hydrant issues to LAPD SLO Matt Kirk.	Dumping bulky items on City/County property is a crime and contributes to safety and sanitation issues. If you see this happening, take photos and report to Sheriff or LAPD officers listed here.	Full Sanitation clean ups require notice to encampment residents, allow them to remove belongings before sanitizing. They are allowed to return by law. Social service/ mental health/LAPD accompany sanitation crews.
Living in Vehicles	Prohibited almost everywhere in Brentwood, although the rule has been temporarily halted due to Covid.	If you can do so safely, please leave a note on the vehicle referring the occupant(s) to <u>Safe Park LA;</u> cars cannot park more than 72 hours in one spot.	Take photos of vehicle, license & location; report to LAPD SLO Matt Kirk 34713@lapd.online; report vehicle to Parking Enforcement dispatch at (213) 485-4184 - the more people who contact the homeless, the more likely they will accept services.
